Bridge removal bid for the demolition of county bridge number C007402110, located on 640 Avenue, approximately ½ mile north of 716 Road. This project shall include all labor, materials, transportation and equipment required for removing all steel, timber piling and bridge planks from the channel and removing the timber abutments and removing any other miscellaneous items associated with the bridge. All materials will become the contractor’s responsibility and must be removed from the site.
